**Subject: Transfer of all six months courses under Craftsmen Training Scheme to Modular Employable Courses under Skill Development Initiative Scheme.-reg.**


Sir,

The 41<sup>st</sup> meeting of the National Council for Vocational Training (NCVT) under the Chairmanship of Hon'ble Minister of Labour & Employment, was held on 30<sup>th</sup> April, 2014. The above subject was discussed in the meeting vide item No.4103.1 of agenda.

2. A Working Group (WG) was constituted by M/o Labour & Employment for examining all aspects of the various DGE&T schemes including Craftsmen Training Scheme (CTS) and suggest improvements therein. WG recommended that all six months courses under the CTS be transferred into Modular Employable Courses under Skill Development Initiative (SDI) Scheme. The recommendation of WG was further put up for approval of NCVT during its 41<sup>st</sup> meeting and Council approved that all six months courses under the CTS be transferred into Modular Employable Courses under Skill Development Initiative Scheme.

3. Government of India has accepted the above recommendations of the council for implementation with immediate effect. Accordingly, all six months courses under CTS shall be discontinued with immediate effect and transferred to Modular Employable Courses under SDI Scheme. All concerned are requested to stop admission in 6 months trade under CTS and implement them under SDI Scheme.


