## ORDER

As per the letter read above, the Managing Director, KELTRON has  
requested Government to issue orders for replacing conventional Tube Lights  
by Energy Efficient LED Tube Lights in all Government buildings and to appoint  
them as Nodal Agency for supply of its own manufactured products.

As per the Government Order read as 2nd above, Government have  
designated KELTRON as the nodal agency for the supply of KELTRON's  
own manufactured products and have constituted a Price Fixation Committee for  
fixing the price of KELTRON's LED Tube Lights so as to enable them to supply  
the product to all Government Departments/Public Sector Undertakings/Local Self

Government Institutions/Autonomous Bodies, etc. without following tender formalities, placing the Joint Secretary, Stores Purchase Department as Chairman and the Managing Director, KELTRON as the Convenor. The Price Fixation Committee held on 11-7-2014, fixed the price of KELTRON's LED Tube Lights.

Government have examined the matter in detail and are pleased to accord sanction to M/s. KELTRON to supply its own manufactured LED Tube Lights to various Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies, etc. without following tender formalities, invoking relaxation to para 9.23 of Stores Purchase Manual, for a period of one year from the date of issuance of this Government Order.

Government have approved the rate of ₹ 1,750 for KELTRON's LED Tube Lights fixed by the Price Fixation Committee. The price is inclusive of the present rate of Excise Duty and Sales Tax and will vary to the extent of changes made in these by Government, from time to time.

All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies, etc. can purchase KELTRON's own LED Tube Lights as per their requirement, without following tender formalities in relaxation to para 9.23 of the Stores Purchase Manual subject to the condition that the price of the item should not exceed the selling price fixed by the Government as specified above for a period of one year with effect from the date of this Government Order. The Purchasing Officer should ensure that the period of validity of the said relaxation is in force at the time of purchase.
