CIRCULAR

Sub:- Observance of 'Constitution Day' on 26<sup>th</sup> November 2015  
in all Educational Institutions and Government  
Departments - Instructions issued - Regarding.

As part of celebrating the 125<sup>th</sup> birth anniversary of Dr. B.R. Ambedkar, Government of India has decided to start celebrating 'Constitution Day' on 26<sup>th</sup> November 2015 in commemoration of the adoption of Indian Constitution on 26<sup>th</sup> November 1949. In connection with the celebrations, Government of India has decided to read out 'Preamble' to the Constitution (as it exists today) in all educational institutions and Government offices throughout the country. It has also been directed to organise mock parliament, Essay/Debate competitions and lectures to increase the awareness about the constitution of India among people and students of universities and colleges.

In this connection, all District Collectors, Heads of Departments and Chief Executives of Public Sector Undertakings/Autonomous Bodies are directed to arrange programmes for observing 'Constitution Day' on 26<sup>th</sup> November 2015 (Thursday) by reading out 'Preamble' to the Constitution at 11.00 a.m in your office and subordinate offices under your control. Also all educational institutions are directed to read out the 'Preamble' to the Constitution during the assembly session. 'Preamble' to the Constitution is appended herewith.




