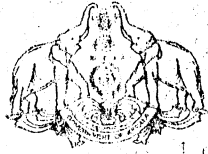

ORDER

1. Government have introduced Ex-gratia Family Pension to the spouse of Ex-gratia pensioners with effect from 1-7-2014 vide Government Order read above. The Accountant General (A&E) in the letter read above, has sought clarification regarding modalities and mechanism for incorporation of name of spouse in the PPO in respect of the Ex-gratia pensioners who are alive and in case of employees retiring from service after the date of order.

2. Government have examined the matter in detail and are pleased to order the following procedures for incorporation of the name of spouse in the PPO in respect of the Ex-gratia pensioners.

(a) In case of Ex-gratia pensioners retired prior to the date of this order—The pensioners shall furnish details of spouse in form SA along with joint photograph to the Head of the Department. The Head of Department along with sanction order, forward the same to the Accountant General for incorporating the name of the spouse in the PPO.

(b) In case of employees eligible for Ex-gratia pension and are retiring from service on or after the date of issuance of order—the procedure as prescribed in Rule 90 (13)(i) and (ii) of part III KSR shall be made applicable. Joint photograph shall also be furnished along with application for pension as in the case of service pensioners.
