ORDER

As per the letter read as 1st paper above, the Director of Training has furnished proposal to accord administrative sanction for up-gradation of five (5) Women ITI's (Chengannur, Kalamassery, Malampuzha, Chalakkudy, Kannur) at a total cost of ₹ 9, 84,53,816 (Rupees Nine crores Eighty four lakhs Fifty three thousand Eight hundred and Sixteen only).

2. The proposal was placed before Special Working Group meeting held on 11.10.2013 and was approved subject to the specific condition that post creation is not admissible under the scheme and the staff shall be provided through re-deployment. The component and estimated cost of the scheme is as follows:-

3. In the circumstances, Administrative Sanction is accorded for the upgradation of the five (5) women ITI's (ITI for Women Chengannur, Kalamassery, Malampuzha, Chalakkudy, Kannur) at a total cost of ₹ 7.70.78.818 (Rupees Seven crore seventy lakh seventy eight thousand eight hundred and eighteen only). subject to the condition that Post creation is not admissible and the required staff shall be provided through re-deployment and also subject to the following general conditions:-

1. The expenditure would be met from the provision available under the appropriate head of account and the expenditure shall be limited within the current year's budget provision and no additional fund shall be provided.
2. Store Purchase Rules shall be strictly adhered to.
3. Tender /e-tender and other stipulated formalities shall be followed wherever necessary
4. For civil works, CPWD rates shall be followed from 01.10.2013.


