ORDER

The Secretary, Kerala Legislature Secretariat as per reference (1) read above, informed the Government, the recommendation of the Subject Committee-VII (Electricity, Labour and Labour Welfare), that the ITI's working under the SC/ST Development Departments should be brought under the Industrial Training Department, considering the poor condition of these ITI's.

In the circumstance, a meeting was convened under the chairmanship of Hon'ble Minister for Labour and Rehabilitation with the Hon'ble Ministers for SC Development and ST Development to explore the possibility of bringing the ITI's of SC/ST Development Department under the control of Labour Department. In the meeting held on 25.06.2013, the Scheduled Tribe Development Department fully agreed to the proposal of taking over of the two (2) ITI's working under that Department by Industrial Training Department.

3. The Director of Training as per the letter read as 3rd paper above sought necessary orders for taking over the two ITI's, i.e. ITI Kuttamala in Thiruvananthapuram District, and ITI Nadukani in Idukki District now under the Scheduled Tribe Development Department by the Industrial Training Department. Government examined the proposal submitted by the Director of Training in detail, and are pleased to order the taking over of the two ITI's (i.e. ITI Kuttamala in Thiruvananthapuram District, and ITI Nadukani in Idukki District) by the Industrial Training Department from the control of Scheduled Tribe Development Department.

4. The Director of Training should take further steps to approach the Revenue Department to get the land and building of these two ITI's, in possession of the Industrial Training Department.


