**ORDER**

Government have revised the pay and allowances of State Government Employees as per Government Order 2<sup>nd</sup> cited. The Director of Insurance in his letter read as 3<sup>rd</sup> paper above has recommended to revise the SLI premiums of the employees in commensurate with their pay ranges and in terms of revision ordered in pay scales.

Government after having examined the proposal in detail, are pleased to revise the SLI premium of State Government Staff whose pays and allowance have been revised by Government and employees come under SLI purview as per rule extant as detailed below in modification to Rule 4 (1) of State Life Insurance Rules.

Pay Range Rate (Revised scales of pay)	Existing rate (relates to old scale)	Enhanced
Basic pay up to Rs. 9189/-	Rs. 120/-	Rs. 150/-
Basic pay from Rs. 9190-18739/-	Rs. 175/-	Rs. 225/-
Basic pay from Rs. 18740-29179/-	Rs. 300/-	Rs. 375
Basic pay from Rs. 29180/- onwards	Rs. 350/-	Rs. 450/-

The revised rates will come to force with effect from 1.4.2012, ie., salary for the month of March 2012

Employees now subscribing State Life Insurance Scheme and eligible for additional policies should take additional policies covering the balance premia immediately. The Government Order will be available in internal and official website of the Government of Kerala


