
In respect of some of the trades/units permission to trainees has not been given due to major deficiencies/discrepancies. The institutes/trades for which instructions have already been issued, may not be found covered in the above annexures.

The institutes/trades, started in 1982 or before, which have not been granted permanent affiliation so far, including those covered in annexures 'A', 'B' and 'C', stand de-recognised.

Any information given in the annexures mentioned above should be deemed to a repetition and not an additional one if any other information/instruction has already been issued or is covered in the above annexures for the same purpose.

6. Any discrepancy observed by you, after comparing the details of the above annexures, with your records may please be brought to the notice of this Directorate. The above annexures do not cover those institutes/trades for which inspection reports have been received after July, 1985. Such reports would be scrutinised in due course of time for considering affiliation.
7. In cases, where conditional affiliation has been granted, State Director is requested to confirm within 3 months that the condition imposed has been met with and the discrepancies have been removed. If confirmation is not received, affiliation granted is likely to be withdrawn.
8. Informations desired vide this Directorate letter No. DTT-5(10)/84-TC dated 18th May, 1985 is not already sent, may please be forwarded immediately as the same is required for the comparison with our records.

Sir,

The Standing Committee Inspection Reports (SCIRs), Departmental Inspection Reports(DIRs)and Supplementary Inspection Reports (SIRs) forwarded by you were scrutinized and put up before the members of the Sub-Committee of National Council for Vocational Training (NCVT) dealing with affiliation in its meeting held on 31.01.2005 at DGE&T Hqrs., New Delhi for its consideration and approval

The Committee examined various affiliation cases and accorded approvals in deserving cases.

A copy of the statement containing the names of ITIs /ITCs/Trades/Units in respect of your State which have been approved/rejected, along with remarks indicating the conditions for affiliation etc. duly signed is enclosed. On the basis of this you may issue the affiliation orders to the Management of the concerned ITIs/ITCs which have been approved whereas to the others institutes affiliation orders be issued after the stipulated conditions/action as stated in the remarks column for compliance. The conditions stated for grant of affiliation should be clearly conveyed to the respective institute stating that the deficiencies under Remarks column are to be made up. The other conditions of affiliation, if any, are to be complied with before the affiliation order is issued by you.

Your attention is also drawn to the effective date (i.e. SCIR/DIR/date) of the trades/units kept "under consideration-(UC)". The trainees admitted in the trades/units kept as "UC" may be allowed to appear in the All India Trade Test for Craftsman provided they have completed the training period from the date the trade/unit has been kept UC i.e. the trainees admitted in the academic session from which affiliation has been kept under consideration and not of earlier batches. However, the Supplementary Inspection Reports(SIR) in respect of all such UC cases should be submitted within three month positively, so that these UC cases can be put before the next meeting of the Sub-Committee

of NCVT for its consideration /approval and if the UC stands withdrawn. In case the institute fails to make up the deficiencies within the stipulated time limit of three months, it will be responsibility of the concern State Director to inform the institute the UC stands withdrawn and fresh Standing Committee Inspection /Departmental Inspection depending upon the case is required to be done in such cases under intimation to this Directorate General.

It may please be noted that, the cases, which have been rejected in variably, require fresh standing committee inspection / Departmental inspection depending upon the case for grant of affiliation of trades / units. Accordingly institute may please be advised.

You are also requested to quote DGE&T file number as indicated below the institute's name in the list enclosed, while making future correspondence related to respective ITI's/ ITC's.

The recommendations of the Sub-Committee have been brought in the minutes of the meeting. A copy of the Statement containing the names of ITIs/ITCs/Units/Trades with remarks indicating the conditions for recommending affiliation etc. duly signed is enclosed.

On the basis of that, you may issue the affiliation orders to the Management of the concerned III/IIC after confirming:-


- i) defects and deficiencies observed under 'Remarks' column 6 are made good.
- ii) the conditions of affiliation, if any, you are complied with.

You are requested to Quote File No. indicated below the institute's name in the list enclosed as dated 29.1.97 in all future correspondence relating to these ITIs/Trades/Units.

It may clearly be noted that where ever Not Recommended (NR) or 'Not Considered' (NC) has been mentioned, in column 5 of the enclosure, the concerned institute may be instructed not to admit the trainees from the next session and the trainees if any under going training in such trades/units in such ITIs shall not be permitted to appear in All India Trade Test by NCVT. It has also been observed that some State Directors allow the trainees of un-affiliated institutes to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET has to change the procedure for issue of National Trade Certificate's and as such trainees will not be given NCVT Certificates.


