

The institutes/trades, started in 1982 or before, which have not been granted permanent affiliation as yet, including those covered in annexures 'A', 'B' and 'C', stand de-recognised.

Any information given in the annexures mentioned above should be deemed to a repetition and not an additional one if any other information/instruction has already been issued or is covered in the above annexures for the same purpose.

6. Any discrepancy observed by you, after comparing the details of the above annexures, with your records may please be brought to the notice of this Directorate. The above annexures do not cover those institutes/trades for which inspection reports have been received after July, 1985. Such reports would be scrutinised in due course of time for considering affiliation.
7. In cases, where conditional affiliation has been granted, State Director is requested to confirm within 3 months that the condition imposed has been met with and the discrepancies have been removed. If confirmation is not received, affiliation granted is likely to be withdrawn.
8. Informations desired vide this Directorate letter No. DWT-5(18)/84-TC dated 18th May, 1985 is not already sent, may please be forwarded immediately as the same is required for the comparison with our records.

Sir,

The Standing Committee Inspection Reports ( SCIRs ), Departmental Inspection Reports ( DIRs ) and Supplementary Inspection Reports ( SIRs ) forwarded by you were scrutinised at this Directorate General and recommendations of Directorate General of Employment and Training (DGET) were put up before the Sub Committee of National Council for Vocational Training ( NCVT ) dealing with affiliation in the meeting held on 20<sup>th</sup> April 2000 at DGET Hqrs New Delhi. The recommendations of the Sub - Committee have been brought in the minutes of the Meeting. A copy of the Statement containing the names of ITIs /ITCs/Units/Trades in respect of your State, with remarks indicating the conditions for recommending affiliation etc. duly signed is enclosed on the basis of which, you may issue the affiliation orders to the Managements of the concerned ITIs / ITCs / Units / Trades, indicating:

- 13. Defects and deficiencies under " Remarks " column are to be made good.
- 14. The conditions of affiliation, if any, are to be complied with.

⊙ Your special attention is drawn to the effective date mentioned against the Trades/ units kept " Under Consideration " ( UC ). The trainees admitted in the trades/ units kept " UC " may be allowed to appear in the All India Trade Test for Craftsman provided they have completed the Training period from the date the trade is kept " UC " i.e., the trainees were admitted from the date the trade is kept " UC ". However, the SIRs in respect of all such cases should be submitted within three months.

You are requested to quote DGET file No. indicated below the institute's name in the list enclosed as dated 20<sup>th</sup> APRIL, 2000 in future correspondence relating to these ITIs / trades /units.


It may clearly be noted that wherever " Not Recommended " ( NR ) has been mentioned against trades / Units, the concerned institute may be instructed not to admit the trainees from the next session and the trainees, if any, undergoing training in such trades / units in such ITIs / ITCs shall not be permitted to appear in All India Trade Test by NCVT. It has also been observed that some State Directors allow the trainees of unaffiliated institutes/trades to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET is facing a lot of Court Cases.

The State Directors are requested to communicate to the concerned institutes about the recommendations within a month from the date of issue of this letter under intimation to this Directorate General. Further, the SIRs in respect of the cases kept under consideration ( UC ) must be forwarded to this office within three months failing which the cases will be considered as closed. Thereafter, fresh SCIR will be required, even for such cases which have been kept under consideration due to minor deficiencies.

You are aware that Sub Committee of NCVT dealing with affiliation approved a modified Annexure III-A and State Directors were requested to submit Standing Committee Inspection Reports ( SCIRs ) with modified annexure ~~III~~ vide: our letter 12/1/99- TC dated 26.11.1999. It is reiterated that the all SCIRs may be forwarded with modified Annexure III-A.
