

However, the Supplementary Inspection Reports (SIRs) in respect of all such UC cases should be submitted within three month positively, so that these cases can be put to the Sub-Committee of NCVT in its next meeting.

In case the institute fails to make up the deficiencies within the prescribed time limit of three months, it will be responsibility of the concerned State/ U.T Director to inform the institute that U.C. stands withdrawn and fresh standing committee inspection report/ Departmental inspection report depending upon the case is required to be done in such cases under intimation to this Directorate General.






