Sir,

The Standing Committee Inspection Reports (SCIRs), Departmental In Reports(DIRs)and Supplementary Inspection Reports (SIRs) forwarded by you , were before the members of the Sub-Committee of National Council for Vocational Training dealing with affiliation in its meeting held on 20<sup>th</sup> March ,2007 at DGE&T Hqrs., N for its consideration and approval.

C The Committee examined various affiliation cases and accorded approvals in d cases.

A copy of the statement, duly signed, containing the names of ITIs /ITCs/Trade in respect of your State which have been approved/rejected, along with remarks indica conditions for affiliation etc. is enclosed. On the basis of this, affiliation orders may be to the Management of the concerned ITIs/ITCs which have been approved, whereas other institutes, orders are to be issued for the conditions/action (as stated in the column) for compliance. The conditions stated for grant of affiliation should be clearly c to the respective institute stating that the deficiencies under Remarks column are be n The other conditions of affiliation, if any, are to be complied with before the affiliation issued by you.


Your attention is also drawn to the effective date (i.e. SCIR/DIR/date) trades/units kept "under consideration - (UC)". The trainees admitted in the trades/un as "UC" may be allowed to appear in the All India Trade Test for Craftsman, provided th completed the training period from the date the trade/unit has been kept UC i.e. the admitted in the academic session from which affiliation has been kept under

Consideration and not of earlier batches. However, the Supplementary Inspection Reports in respect of all such UC cases should be submitted within three month positively, so that UC cases can be put before next meeting of the Sub-Committee of NCVT for its consideration /approval failing which UC stands withdrawn. In case the institute fails to make deficiencies within the prescribed time limit of three months, it will be the responsibility of concern State Director to inform the institute that the UC stands withdrawn and fresh Standing Committee Inspection /Departmental Inspection (depending upon the case) is required to be done in such cases under intimation to this Directorate General.

It may please be noted, that the cases which have been rejected in variably, require fresh standing committee inspection / Departmental inspection depending upon the case, for grant of affiliation of trades / units. Accordingly the institute may please be advised.

You are also requested to quote DGE&T file number as indicated below the institute's name in the list enclosed, while making future correspondence related to respective ITI's/ ITCs.
