Subject: Exemption of duration of time for completing all the four module of CITS programme on modular pattern during the extended period i.e. during 2015-16.

Sir/Madam

This has been brought to the notice of this DGT, HQ that a large number of instructors across the states have completed some of the modules of CITS on modular pattern during year 2011 to 2013. However they have not completed the all four modules during the stipulated period of 3 years for completing the course and award of National Craft Instructor Certificate.

In order to give opportunity to all those instructor who have earlier completed some of the modules of CITS, to complete the programme during the extended period i.e. during 2015-16, it has been decided by the competent authority to give one time relaxation, so as to complete the course irrespective of total duration of time for completing all the modules which is 3 years.

You are, therefore, requested to depute all those Vocational Instructors across all ITIs of your respective states, who have completed some of the modules, to complete their remaining modules of CITS on modular pattern, irrespective of prescribed duration of time limit of three years, during extended period of year 2015-16. These instructors would have last opportunity to complete the course.
