In the above circumstances, in order to avoid delay in reporting vacancies to KPSC, all Heads of Departments and Appointing Authorities are hereby directed to report all existing/arising vacancies (those which are to be reported to Kerala Public Service Commission) in each category of posts, to KPSC and to furnish the details to Personnel and Administrative Reforms (Advice-C) Department in the following format on a monthly basis. Government will monitor the reporting of vacancies and violation of these instructions by any Head of Department and Appointing Authority will be viewed seriously.
