

ORDER

M/s. Foam Mattings (India) Ltd. (FOMIL), a Public Sector Undertaking of Kerala State vide letters read above has requested Government to grant them the permission for doing Interior Decoration Work in various Government Departments/Public Sector Undertakings/ Local Self Government Institutions/Autonomous Bodies etc., without following tender formalities. The firm has offered a discount of 10% for their products, if they are used for the decoration.

As per Government Order read as 1st above, the Industries Department has permitted all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc., to buy coir products exclusively for furnishing purpose, directly from institutions like Coirfed, Foam Mattings (India) Ltd. (FOMIL) etc. without quotation.

Government have examined the matter in detail and are pleased to accord sanction to M/s. Foam Mattings (India) Ltd. (FOMIL) for doing Interior Decoration Work in all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc., without observing tender formalities involving relaxation to para 9.23 of Stores Purchase Manual for a period of one year, from the date of issuance of this Government Order, subject to the condition that the firm should give 10% discount mentioned therein to their products, used for the decoration.

All Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc. can approach M/s. FOMIL directly for Interior Decoration Work without following tender formalities, and they should ensure that the period of validity of relaxation referred above is in force, while doing the Decoration Work by FOMIL.


