Government of India has approved 'National Apprenticeship Promotion Scheme' (NAPS) with target to provide apprenticeship training to 50 lakh youth by 2020. Under the scheme, Government of India will share 25% of prescribed stipend subject to a maximum of Rs.1500 per month per apprentice with the employers. Government of India will also share maximum Rs.7500 per fresher apprentice (without any formal trade training) as a cost of basic training with Basic Training Providers. The guidelines of the NAPS are available on apprenticeship portal (www.apprenticeship.gov.in), DGT (www.dget.nic.in) and MSDE (www.msde.gov.in) website.

For the promotion of the scheme State Directorate has decided to conduct a meeting with Industrial units including Central/State public sector units, Private sector Establishments for the implementations of National Apprenticeship Promotion Scheme.


