

Subject: Implementation of National Skills Qualifications Framework (NSQF) compliant curricula for five CTS trades w.e.f. August, 2015 session – regarding

Sir/Madam,

You may be aware that National Skills Qualification Framework (NSQF) has been notified vide Gazette Notification dated 27<sup>th</sup> December, 2013 published by Department of Economic Affairs, Ministry of Finance. The NSQF organizes qualifications according to series of levels of knowledge, skill and aptitude. The main thrust of the NSQF is to focus on competency-based qualifications. The paradigm shift from learning focused on inputs to an outcome/competency based training would enable alignment of the Indian qualifications with international ones. 2. In this context, it has been decided to implement the NSQF-compliant curricula for the following five CTS trades under NCVT, w.e.f. the session commencing in August, 2015:

- a) Fitter (NSQF Level 4)
- b) Electrician (NSQF Level 4)
- c) Electronics Mechanic (NSQF Level 4)
- d) Turner (NSQF Level 4)
- e) Welder (NSQF Level 3)

3. The NSQF-compliant competency-based curricula of these five trades have been uploaded at <http://dget.gov.in/content/innerpage/trade-syllabus.php>.

4. Accordingly, it is requested to communicate to all Government and Private ITIs in your State to implement the above-mentioned NSQF-compliant CTS courses w.e.f. August 2015. NCVT is planning to conduct series of workshops/seminars through distance learning network or webinar to disseminate necessary information regarding the implementation, assessment and certification of these trades. The details would be placed on the website and communicated to you through mails. All the concerned like principals, instructors, and Private ITI managements should be encouraged to attend these workshops/seminars.



The Sub-committee approved implementation of following 28 NSQF aligned CTS courses from session starting from August, 2016.







The curricula of above trades have been revised by including new topics relevant to the current market demand (e.g. topics on hydraulics and pneumatics have been added to 'Fitter' trade and also the practical content on CNC turning has been increased in Turner trade). The existing curricula which were introduced in year 2015 shall be discontinued from the forthcoming session. ITIs which have been granted affiliation in existing trades have to create all infrastructure as per the requirement of revised curricula. ITIs desirous of seeking fresh affiliation in these trades are also requested to create infrastructure as per revised norms. The existing affiliated trade/ units for the above 7 trades need to procure the additional tools/ machinery/ equipment within a period of six months from the date of issue of this letter.

Accordingly, State Directors dealing with Craftsmen Training Scheme are requested to issue the necessary instructions to all Government and private ITIs in their State to implement the above-mentioned NSQF-compliant CTS courses w.e.f. session starting in August, 2017.
