Subject:-Supplementary Examination for left over trainees from AITT 2020 exam under CTS (Aug- Sep,2021)

The Directorate General of Training (DGT), Ministry of Skill Development & Entrepreneurship (MSDE) plans to commence the examinations for supplementary candidates and for the trainees who could not attend the AITT 2020 held in the month of Dec,2020 – April 2021. The Computer Based Tests (CBT) for theoretical subjects shall commence from 23rd August, 2021 and the Practical & Engineering Drawing shall be held from Sept. 13, 2021.

2. Earlier, the All India Trade Tests (AITT) 2020 for Craftsmen was held from Dec. 2020 till April 2021. About 14.2 Lakhs trainees were provisioned to appear then. The results were declared in the month of May 2021, wherein, more than 70% of the trainees were declared pass. It was envisaged that the Supplementary examinations for these trainees would be held preferably within 60 days of declaration of the results. Also, the eligible trainees who could not attempt these examinations would be given a chance to appear in these examinations. It was also decided that this chance would not be counted in their regular attempts allowed as per the scheme guidelines, as a Covid relief measure.

3. The fees link for the payment of fees for supplementary examinations have been opened in the NIMI portal. Fees link shall remain open till 10th Aug., 2021 after which the Hall Ticket activities/eligibility process shall be initiated. Trainees are advised to adhere to the timelines as mentioned therein strictly and no further extension shall be given for any activities.

4. Trainees desirous of appearing in the examinations may start depositing their fees as applicable. In addition, payment link shall also remain open for leftover trainees as well, who could not deposit their fees earlier. The trainees who remained absent in the AITT 2020 held from Dec 2020- April 2021, but had paid their fees, need not pay their fees again. However, such trainees are required to update their fees payment details compulsorily using the SoP provided for the purpose on NIMI portal.

5. Extra chance given to the trainees (beyond the allowed attempts) in AITT 2020 is a one time provision only and the trainees not participating in the examination (examination of Aug -Sept. 2021) process shall not be given extra chance other than the allowed attempts as per the scheme.

6. DGT had for the first time introduced online grievance redressal mechanism along-with the results of AITT 2020. About 30,000 grievances related to CBT results and 6,275 grievances related to ED/ Practical results were received. The resolution of the grievances related to CBT may be seen at the NIMI website using the SoP provided. The grievances related to ED/ Practical are being resolved. The trainees declared failed even after the resolution of the grievances and those who have applied in grievances related to profile but declared failed in any subject need to re-apply to appear in this examination. Fees link for such cases will be opened separately.

7. The schedule for supplementary examination for the erstwhile semester scheme (CTS) shall be issued separately.




