CIRCULAR

Sub: Vigilance Department- Combating Corruption at the service points in Government Offices and Public Sector Undertakings-Measures taken for Prevention of Corruption- Display of Notice Boards in Government Offices and Public sector Undertakings-Instructions Issued.

Ref: G.O(P) No. 89/99/Vig dated 06/10/1999.

In order to combat corruption at the service points in Government Offices, Public Sector Undertakings and other Institutions, Government as per the order cited above have issued instructions for displaying notice boards to spread awareness among general public on anti corruption measures. It has come to the notice of Government that many Government Offices and Public Sector Undertakings and other institutions have failed to adequately display such boards. Further, Government have decided to update such boards by providing latest information on how the Vigilance and Anti Corruption Bureau can be approached to give any information on corruption. Therefore it is hereby directed that all offices of the Government, Public Sector Undertakings and other Institutions shall display a notice board in the following format in English and Malayalam at prominent places in the buildings housing such offices.
