

1.0 Background of Craft Instructor Training Scheme

- 1.1 Training of Craft Instructors is the mandated responsibility of Directorate General of Training (DGT) and it has been operational since the inception of the Craftsmen Training Scheme (CTS). Comprehensive training both in hands-on-skills and training methodology is imparted to the instructor trainees to make them conversant with techniques of transferring hands-on-skills, to train skilled manpower which is industry ready.
- 1.2 DGT has mandated that all trainers in Industrial Training Institutes (ITIs) must possess National Craft Instructor Certificate (NCIC) under Craft Instructor Training Scheme (CITS). India has around 15,000 ITIs (Govt. & Pvt.) of which 85% are run by the private sector and 15% are State government/UT administration or any other government-funded organisation.
- 1.3 All ITIs put together have around 25 lakh seats per annum and need around 2.0 lakh instructors. At present craft instructors are trained in 40 CITS trades that covers 59 CTS trades and training is conducted in 14 National Skill Training Institutes (General), 19 National Skill Training Institutes (Women), 6 State Government Institute of Training of Training of Training of Training of Training of Training Courses are aligned with National Skill Qualification Framework (NSQF) and approved by National Council for Vocational Education and Training (NCVET).

2.0. Need for Recognition of Prior Learning (RPL) under Craft Instructor Training Scheme

2.1 Till 2018, Individuals having 03 or more years' experience as instructor in ITI but not having NCIC were required to undergo training for one year at National Skill Training Institutes (NSTIs)/Institute of Training of Trainers(ITOTs) with fresh ITI pass-out candidates. About 25% seats in these institutes were filled by sponsored in-service candidates who have already acquired the skill during teaching in ITIs for more than 03 years. Government & Private ITIs had in past recruited instructors without CITS qualification, of which the Government ITIs were deputing for CITS



training at NSTIs against the 25% reserved quota for one year. In some cases, due to shortage of instructors and exigencies, they were unable to relieve the instructors for CITS training for one year. The instructors who have experience in providing training to CTS trainees, may require to only up-skill their knowledge and teaching practices to upgrade themselves rather than be treated as fresh candidates, hence, the need was felt to introduce RPL under CITS.

- 2.2 In order to fill the gap between demand and supply, introduction of RPL under CITS was discussed as an Agenda No. 8 in the Committee on Norms and Courses held on 14th February, 2019 under the Chairmanship of Director General/Additional Secretary, Directorate General of Training. After detailed deliberations, the Committee on Norms and Courses approved the introduction of RPL under CITS. The Committee also approved the guidelines. NCVET vide letter no. MSDE-19/02/2018-CD(04) dated 26th July, 2019 has recognised RPL under CITS equivalent to regular one-year CITS.
- 2.3 The RPL scheme was designed for certification of in-service instructors having minimum 03 years of experience and introduced in the year 2019 for 2 years up to December 2020. Trade-wise candidates appeared in the RPL examination conducted during June-July 2019 is annexed at Annexure-1. Due to Covid Pandemic, the RPL examination couldn't be held in time and many in-service instructors couldn't take up the examination, therefore, the Scheme has been extended up to December 2025.
- 2.4 NCVET vide MSDE-19/02/2018-CD(03) dated 26th July, 2019 has mandated that all trainers in ITIs need to be CITS trained. Present capacity in NSTIs and ITOTs may not train and certify required number as Craft Instructors. Hence guidelines for CITS RPL are being further simplified as below: -

3.0 Objective of the Scheme

The scheme of RPL under CITS is meant to recognize and certify the skill of instructor (including long term contract) with at least 03 years' experience in

teaching from an institute for issuance of National Craft Instructor Certificate (NCIC).

4.0 Eligibility of Instructor for appearing in AITT under RPL

- (i) The aspirant should have basic qualification viz. CTS/diploma/degree in that broad sector.
- (ii) The aspirant should have a minimum age limit of 25 years and a maximum age limit of 62 years on specified cut-off date.
- (iii) The instructor (regular/contractual (long term contact)) having at least 03 years of experience of teaching in the institute.
- (iv) The instructor should be sponsored by the institute for applying in this scheme to appear in AITT for RPL under CITS to be conducted by DGT or could apply on his/her own.
- (v) The instructor has to be registered National Instructional Media Institute (NIMI) online portal at least two months before the scheduled date of examination.
- (vi) The instructor has to submit experience/service certificate from State Directorate/Principal.
- (vii) In case of candidates claiming experience from Pvt. ITIs, should produce EPF/ESCI slip.

5.0 Competent Sponsoring Authorities

- (i) State Directorate/Commissioners may nominate their in-service instructors working in any Government ITI affiliated to DGT or State Council for Vocational Training (SCVT) and having minimum 03 year of teaching experience and do not possess NCIC.
- (ii) Principals/Directors of Private ITIs affiliated to DGT or SCVT may sponsor their instructors having minimum 03 years of teaching experience and do not possess NCIC.

6.0 Institute for conduct of examination for RPL and Trade Test curriculum

(i) The AITT in RPL scheme may be conducted on quarterly basis.

- (ii) The AITT for RPL scheme may be conducted for all existing trades running under CITS.
- (iii) Content for subject Training Methodology will be made available at https://bharatskills.gov.in in Blended Mode by NIMI.
- (iv) Mock test facility may also be provided through the portal to facilitate the candidates for practice online exam of theoretical subjects.
- (v) All papers as applicable will be conducted at NSTIs/ITIs with subjective/objective/CBT question paper for Theory and detailed hands-on practical examination & training methodology (Professional Skill)

7.0 Duration of training

- (i) There will be 4 to 8 weeks training in online/offline to the instructors registered for appearing in AITT for RPL under CITS. The self-learning content of one-month training of pedagogy course will be made available at https://bharatskills.gov.in and instructors who are willing to appear for the said examination are advised to study and practice the learning materials/topics before appearing in examination.
- (ii) States are encouraged to conduct in-service training under Training of Trainer Programme for those instructors who do not possess NCIC.
 - (a) They may be given in-house training in the specific area where syllabus may be changed during the time of their experience as instructors and Training Methodology syllabus under CITS scheme of DGT. This training may be given at State IToT or NSTIs(General & Women) or Model ITIs/Divisional ITIs in different states.
 - (b) Mentor will be given from NSTIs and State IToTs to candidates for improving their skill sets as per requirement.
 - (c) The job roles of the instructors are changing day by day, therefore, they may also be given training in digital awareness and some administrative areas so that they may be up-skilled for current scenario for their job role.
 - (d) The up-skill training may be defined in the week-wise predefined schedule and that may be at different places so that they may get good exposure for improving their skill.



8.0 Process of Registration, Assessment and Certification

- (i) The instructor nominated by the competent authority or applying as own has to be registered at NIMI online portal at least before two months from the scheduled date of examination. Format for Registration is annexed at Annexure-2. Non-refundable registration fee of Rs 500/- will be charged by NIMI at the time of registration.
- (ii) Online registration form with Photograph and other details of the Instructor has to be uploaded in portal by concern instructor.
- (iii) The instructor has to select his/her trade/course and name of the institute where he/she is interested to appear for AITT.
- (iv) The nomination/sponsor letter issued by Competent Authority has to be uploaded in specified portal as proof of experience. The online submitted form has to be approved by the concerned RDSDE or State Directorate as acceptance of the candidature for RPL after due physical verification on preannounced schedule date of document verification.
- (v) The assessment / trade test will be conducted for all the papers applicable. The detail of AITT is annexed at Annexure-3.
- (vi) The result of the trade test will be processed through portal for RPL and e-marksheet /e-Certificate will be issued through portal.
- (vii) There will be total 03 attempts to appear in AITT for RPL under CITS i.e. 01 attempt as regular and 02 additional attempts as supplementary to pass the examination.
- (viii) For CTS trades where no CITS is available, the CITS RPL will be based on trade practical, theory based on CTS syllabus and training methodology (Professional Skill)
- (ix) Examination fee will be Rs. 400/- per paper per examination.

9.0 Equivalency of Certificate issued under RPL

(i) NCIC will be issued by NCVET to all passed-out candidates in AITT for RPL under CITS. This NCIC will be at par to the NCIC issued to the passed-out trainees appearing in AITT under CITS after completion of 01 year training in Institutes.



- (ii) The certificate issued under RPL shall be valid for all the purposes for recruitment and promotions in place of regular NCIC.
- (iii) NCVET vide letter no. MSDE-19/02/2018-CD(04) dated 26th July, 2019 has recognised RPL under CITS equivalent to regular one year CITS.

10.0 Rights of Competent Authorities

- (i) State Directorate and DGT have rights to verify the instructor credentials. In case of any irregularity suitable action may be taken against the sponsoring authority and registration of instructor for RPL may be cancelled.
- (ii) DGT, MSDE reserves the right to modify the terms and conditions from time to time for RPL scheme and such modified terms shall be binding on all the stakeholder of RPL under CITS scheme.
- (iii) DGT reserves the right to accept/reject the online registration form of the candidate. In case of submission of any false information submitted during registration the application for RPL may be cancelled.
