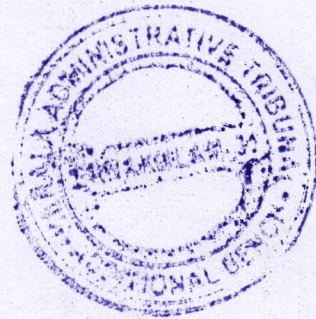

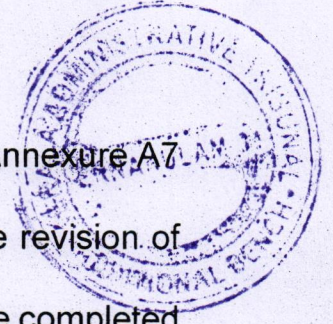

ORDER

The applicant filed this Original Application challenging Annexure A7 seniority list which was published in the year 2016. In the objection to the application for condoning delay and also in the reply statement filed by the third respondent, it was stated that the seniority list of Senior Clerks would be reviewed, as various complaints have been received. It is also stated that the Government has been addressed in the matter and immediately on receipt of instructions from Government appropriate action would be taken to revise the seniority list.

2. Along with M.A.(Ekm) No.1629/2023 the applicant has produced Annexure A10 letter issued by the Government addressed to the 2nd respondent informing that the gradation list of Senior Clerks had to be revised in accordance with the circular issued by the Government on 10.3.2014.

3. In the circumstances, there will not be any objection for the 2nd respondent for revising the seniority list. The Original Application is therefore disposed of with a direction to the 2nd respondent to take steps for revision of Annexure A7 seniority list in accordance with law.



It is made clear that the promotions made on the basis of Annexure A7 seniority list would be purely provisional and subject to the revision of seniority list. The process of revision of seniority list shall be completed within a period of 3 months from the date of receipt of a copy of this order.

The Original Application is accordingly disposed of.

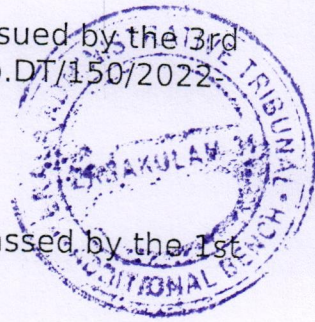
