Sub:- Pay Revision 2009 – Merger of Typist Senior Grade and Typist Selection Grade – Fixation of pay – Clarification issued.

Ref:- GO(P) No. 85/2011/Fin dated 26/02/2011
GO(P) No. 143/2011/Fin dated 30/03/2011.

As per the Government Order cited, the posts of Typist Senior Grade and Typist Selection Grade were merged into a single category viz; Typist Selection Grade with a revised scale of pay of ₹14620-25280. The date of effect of revised scales of pay is 1/7/2009 whereas, the date of effect of improved / new ratio promotion is 1.2.2011 and so requests have been received from various Heads of Departments, Service Organizations and individuals for clarification regarding fixation of pay on promotion as well as revision of scale of pay in respect of typists in various grades w.e.f 1/7/2009.

2. Government have examined the matter in detail and are pleased to issue the following clarifications in this regard.

- i Those who are in the Senior Grade / Selection Grade as on 01/07/2009 shall come over to the revised scale of pay of ₹14620-25280 with effect from 01/07/2009 or any subsequent date. They are not subject to restriction in Rule 7 of Annex II of the reference cited
- ii Those who were promoted as Senior Grade / Selection Grade between 01/07/2009 and 31/01/2011 shall also exercise option vide para 7(2) of Annex II of the reference cited to the revised scale of the promoted post in the scale of pay of ₹14620-25280.
- iii Those who were eligible for promotion as Senior Grade / Selection Grade against vacancies arose up to 31/01/2011 but not promoted due to administrative delay shall also be promoted as Senior Grade / Selection Grade in the revised scale since the revised ratio promotion came to effect only w.e.f 1/2/2011. That is, in the case of those who are eligible for promotion as Senior

Grade Typist up to 31/01/11, their pay has to be fixed in the scale of pay of ₹14620-25280 under Rule 28(A) subject to option (a) or (b). But in the case of those who are already promoted to Selection Grade, as the scale of pay of feeder post and promotion post are the same, their pay has to be fixed under para 41 (v) of the Pay Revision Order.
