Subject: Standing/Departmental Committee Inspection for affiliation of trades/units of Government/Private ITIs with NCVT

Sir,

C Your kind attention is invited to DGE&T letter no.DGE&T-19(22)/2012-CD dated 6th August, 2012, vide which it was informed that all applications for affiliation of ITIs by NCVT should be submitted to Quality Council of India (QCI) from 1st September, 2012, onwards. This order supersedes all previous orders related to grant of affiliation to ITIs by NCVT.

In view of above, it has been decided that the affiliation inspections of ITIs would be continued **only up to 31st August, 2012** as per the present affiliation procedure. However Quality Council of India will start its affiliation procedure from 1st September, 2012, onwards. No preliminary and standing committee would be carried out after 31st August, 2012.

C You are, therefore, requested to organise all the affiliation inspections of ITIs by standing committee within the given time limit utilising all resources in your respective State and must complete all affiliation work by 31st August, 2012 so that these affiliation inspection reports are received in DGE&T by 7th September 2012.
