**Sub:- Implementation of New Pattern of Question Papers.**

Dear Sir,

In continuation to this Directorate even letter number dated 2<sup>nd</sup> Dec. 2011 in which it was informed to All the States/UT Directors (dealing with Craftsmen Training Scheme) that the All India Trade Test for the one year trades will be conducted in the changed pattern of the examinations from July/August 2012, onwards for COPA, Carpenter, Plumber, Sheet-metal & Allied Trades (Engineering Drawing & Workshop Calculation & Science) trades. For the two year trades viz (MMV, Wireman, R&TV, Mechanical Electronics Allied Trades (Engineering Drawing & Workshop Calculation & Science), the test will be conducted in July/August 2013.

2. NIMI has prepared the Question Paper for the Mock Test, for the trades of Carpenter, Plumber and Sheet Metal Worker to be conducted on 22.2.2012 and COPA on 27.2.2012. NIMI has also prepared the question bank for allied trades like Workshop Science & Calculation trade (Fitter, Machinist and Turner), and Engineering Drawing (Fitter, Machinist and Turner) the mock tests are to be conducted on 23.2.2012 and 24.2.2012 respectively.

3. NIMI has also made arrangement to send these Question papers through e-mail to all the States/UTs Directorates so that you may download these on different dates by using the password which will be provided by NIMI. The downloaded question papers can be multiplied either through electronic media or hard copies at their level for distribution to different ITIs/ ITCs.

The entire concerned are requested to take necessary action at their end to hold the Mock test & send the report to DGET after completion of Mock test.
