



The institutes/trades, started in 1982 or before, which have not been granted permanent affiliation so far, including those covered in annexures 'A', 'B' and 'C', stand de-recognised.

Any information given in the annexures mentioned above should be deemed to a repetition and not an additional one if any other information/instruction has already been issued or is covered in the above annexures for the same purpose.

6. Any discrepancy observed by you, after comparing the details of the above annexures, with your records may please be brought to the notice of this Directorate. The above annexures do not cover those institutes/trades for which inspection reports have been received after July, 1935. Such reports would be scrutinised in due course of time for considering affiliation.
7. In cases, where conditional affiliation has been granted, State Director is requested to confirm within 3 months that the condition imposed has been met with and the discrepancies have been removed. If confirmation is not received, affiliation granted is likely to be withdrawn.
8. Informations desired vide this Directorate letter No. DWT-5(1935) 84-TC dated 18th May, 1935 is not already sent, may please be forwarded immediately as the same is required for comparison with our records.
