

The Standing Committee Inspection Reports (SCIRs), Departmental Inspection Reports (DIRs) and Supplementary Inspection Reports (SIRs) forwarded by you were scrutinised at this Directorate General and recommendations of the DGET were put up before the members of the Sub-Committee of NCVT dealing with affiliation at its meeting held on 18.7.1996 at DGET Hqs., New Delhi. The recommendations of the Sub-Committee have been brought in the minutes of the meeting. A copy of the statement containing the names of ITIs/ITCs/Units/Trades with remarks indicating the conditions for recommending affiliation etc. duly signed is enclosed.

On the basis of that, you may issue the affiliation orders to the Management of the concerned ITI/ITC after confirming:-

- i) defects and deficiencies observed under 'Remarks' column 6 are made good.
- ii) the conditions of affiliation, if any, you are complied with.

You are requested to quote File No. indicated below the institute's name in the list enclosed as dated 18.7.1996 in all future correspondence relating to these ITIs/Trade/Units.

It may clearly be noted that where ever Not recommended (NR) or 'Not Considered' (NC) has been mentioned, in column 5 of the enclosure, the concerned institute may be instructed not to admit the trainees from the next session and the trainees if any under going training in such trades/units in such ITIs shall not be permitted to appear in All India Trade Test by NCVT to be held in July next. It has also been observed that some State Directors allow the trainees of un-affiliated institutes to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET has to change the procedure for issue of National Trade Certificate's and as such trainees will not be given NCVT certificates.

The State Director are requested to intimate the institution concerned about the recommendation with-in a month from the date of issue of this letter under intimation to this office. Further the SIR/DIR in respect of the cases kept under consideration (U.C.) must be forwarded to this office within three months failing which the case will be considered as closed and only fresh SCIR will be required.

The recommendations of the Sub Committee have been brought in the minutes of the Meeting. A copy of the Statement containing the names of ITIs/IICs/Units/Trades in respect of your State, with remarks indicating the conditions for recommending affiliation etc. duly signed is enclosed.

On the basis of that, you may issue the affiliation orders to the Managements of the concerned ITIs/IICs/Units/Trades, indicating:

1. Defects and deficiencies under 'Remarks' column 6 are to be made good.
2. The conditions of affiliation, if any, are to be complied with.
3. It has been resolved in the meeting that the trainees belonging to the trades/units kept under consideration (UC) may be allowed to appear in the ensuing All India Trade Test for Craftsmen. However, the SIRs in respect of all such cases should be submitted within three months and no admissions in August, 1978, should be made till the cases are not cleared by DGET.

It may clearly be noted that wherever Not Recommended (NR), Not Considered (NC) has been mentioned, in column 5 of the enclosure, the concerned institute may be instructed not to admit the trainees from the next session and the trainees if any, undergoing training in such trades/units in such ITIs shall not be permitted to appear in All India Trade Test by NCVT. It has also been observed that some State Directors allow the trainees of unaffiliated institutes/trades to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET

- a) had to change the procedure for issue of National Trade Certificates and such trainees will not be given NCVT certificates and;
- b) is facing a lot of Court Cases.

The State Directors are requested to communicate to the concerned institutes about the recommendations within a month from the date of issue of this letter under intimation to this Directorate General. Further, the SIR/DIRs in respect of the cases kept under consideration (UC) must be forwarded to this office within three months failing which the cases will be considered as closed. Thereafter, fresh SCIR will be required, even for such cases which have been kept under consideration due to minor deficiencies.

The trainees admitted in the trades/units kept as "UC" may be allowed to appear in the All India Trade Test for Craftsman provided they have completed the training period from the date the trade/unit has been kept UC i.e. the trainees admitted in the academic session from which affiliation has been kept under consideration and not of earlier batches. However, the Supplementary Inspection Reports (SIR) in respect of all such UC cases should be submitted within three months positively, so that these UC cases can be put before next meeting of the Sub-Committee of


