Subject: Affiliation of ITIs/ITCs/Trades/Units

The Standing Committee Inspection Reports (SCIRs), Central Inspection Reports (DIRs), and Supplementary Inspection Reports (SIRs) forwarded by you were scrutinised by the Directorates and recommendations of the DGET put up before the members of the Sub-committee of NCVT dealing with affiliation at its meeting held on 7.2.96 at New Delhi. The recommendations of the Sub-committee have been brought in the minutes of the meeting. A copy of the statement containing the names of ITIs/ITCs/Units/Trades and remarks indicating the conditions for recommending affiliation etc. duly signed is enclosed.

On the basis of that, you may issue the affiliation orders to the Management of the concerned ITI/ITC after confirming :-

- i) defects and deficiencies observed under 'Remark' column 6 are made good.
- ii) the conditions of affiliation if any are

You are requested to enter the file no., and below the institute's name in the list enclosed as dated 7.2.96 in all future correspondence relating to these ITIs.


It may strictly be noted that wherever 'Not recommended' (NR) or 'Not Considered' (NC) has been mentioned, in column 5 of the enclosure, the concerned institute may be instructed not to admit the trainees from

the next session and the trainees if any undergoing such trades/units in such ITIs shall not be permitted to appear in All India Trade Test to be held in July next. It has also been observed that some State Directors allow trainees of un-affiliated institutes to appear for WCVT examination. This should not be done at all. In this regard it may be stated that as a result of this irregularity by some State Directors, DGT has to change the procedure of issue of National Trade Certificate and as such, such trainees will not be given WCVT certificate.




In respect of some of the trades/units permission to trainees has not been given due to major deficiencies/discrepancies. The institutes/trades for which instructions have already been issued, may not be found covered in the above annexures.

The institutes/trades, started in 1982 or before, which have not been granted permanent affiliation so far, including those covered in annexures 'A', 'B' and 'C', stand de-recognised.

Any information given in the annexures mentioned above should be deemed to a repetition and not an additional one if any other information/instruction has already been issued or is covered in the above annexures for the same purpose.

6. Any discrepancy observed by you, after comparing the bills of the above annexures, with your records may please be brought to the notice of this Directorate. The above annexures do not cover those institutes/trades for which inspection reports have been received after July, 1985. Such reports would be scrutinised in due course of time for considering affiliation.
7. In cases, where conditional affiliation has been granted, State Director is requested to confirm within 3 months that the condition imposed has been met with and the discrepancies have been removed. If confirmation is not received, affiliation granted is likely to be withdrawn.
8. Informations desired vide this Directorate letter No. DWT-6(138) 84-TC dated 18th May, 1985 is not already sent, may please be forwarded immediately as the same is required for the purpose of comparison with our records.

On the basis of that, you may issue the affiliation orders to the Management of the concerned III/ITC after confirming:-


- i) defects and deficiencies observed under 'Remarks' column 6 are made good.
- ii) the conditions of affiliation, if any, you are complied with.

You are requested to quote File No. indicated below the institute's name in the list enclosed as dated 29.1.97 in all future correspondence relating to these ITIs/Trades/Units.

It may clearly be noted that where ever Not Recommended (NR) or 'Not Considered' (NC) has been mentioned, in column 5 of the enclosure, the concerned institute may be instructed not to admit the trainees from the next session and the trainees if any under going training in such trades/units in such ITIs shall not be permitted to appear in All India Trade Test by NCVT. It has also been observed that some State Directors allow the trainees of un-affiliated institutes to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET has to change the procedure for issue of National Trade Certificate's and as such trainees will not be given NCVT Certificates.


The State Director are requested to intimate the institution concerned about the recommendation with in a month from the date of issue of this letter under intimation to this office. Further the SIR/DIR in respect of the cases kept under consideration (UC) must be forward to this office within three months

failing which the case will be considered as closed and only fresh SCIR will be required.
