

Sr,

The Standing Committee Inspection Reports ( SCIRs ) , Departmental Inspection Reports ( DIRs ) and Supplementary Inspection Reports ( SIRs ) forwarded by you were scrutinised at this Directorate General and recommendations of Directorate General of Employment and Training ( DGET ) were put up before the members of the Sub Committee of National Council for Vocational Training ( NCVT ) dealing with affiliation in the meeting held on 4<sup>th</sup> November, 1999 at DGET Hqrs New Delhi. The recommendations of the Sub - Committee have been brought in the minutes of the Meeting. A copy of the Statement containing the names of ITIs /ITCs/Units/Trades in respect of your State , with remarks indicating the conditions for recommending affiliation etc. duly signed is enclosed on the basis of which , you may issue the affiliation orders to the Managements of the concerned ITIs / ITCs / Units / Trades, indicating:

1. Defects and deficiencies under " Remarks " column are to be made good
2. The conditions of affiliation, if any, are to be complied with.

Your special attention is drawn to the effective date mentioned against the Trades/ units kept " Under Consideration " ( UC ). The trainees admitted in the trades/ units kept " UC " may be allowed to appear in the All India Trade Test for Craftsman provided they have completed the Training period from the date the trade is kept " UC " i.e., the trainees were admitted from the date the trade is kept " UC " or later. However, the SIRs in respect of all such cases should be submitted within three months.

You are requested to quote DGET file No. indicated below the institute's name in the list enclosed as dated 4<sup>th</sup> November, 1999 in future correspondence relating to these ITIs / trades / units.

It may clearly be noted that wherever " Not Recommended " ( NR ) has been mentioned against trades / Units, the concerned institute may be instructed not to admit the trainees from the next session and the trainees, if any, undergoing training in such trades / units in such ITIs / ITCs shall not be permitted to appear in All India Trade Test by NCVT. It has also been observed that some State Directors allow the trainees of unaffiliated institutes/ trades to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET is facing a lot of Court Cases.

The State Directors are requested to communicate to the concerned institutes about the recommendations within a month from the date of issue of this letter under intimation to this Directorate General. Further, the SIRs in respect of the cases kept under consideration ( UC ) must be forwarded to this office within three months failing which the cases will be considered as closed. Thereafter, fresh SCIR will be required, even for such cases which have been kept under consideration due to minor deficiencies.

The recommendations of the sub-committee have been brought in the minutes of the meeting. A copy of the statement containing affiliation approval/status for the various ITIs/ITCs/Trades/Units with remarks indicating the conditions for recommending affiliation etc, duly signed is enclosed.

On the basis of above statement, you may issue the affiliation orders to the management of the concerned ITI/ITC. However in respect of recommended cases where ever short coming have been pointed out in the remarks column no. 6, it should be ensured that these have been made up and affiliation order should be issued thereafter.

Also ensure that conditions of affiliation, are complied with.


In all future correspondence relating to these ITIs/Trades/Units You are requested to quote File No. indicated below the institute's name in the list enclosed as dated 24.2.98.

It may clearly be noted that where ever Not Recommended (NR) or Not Considered (NC) has been mentioned, in column 5 of the enclosure, instructions to be followed are as given below.

- The concerned institute may be instructed not to admit the trainees from the next session and the trainees, if any under going training in such trades/units, in such ITIs/ITCs shall not be permitted to appear in All India Trade Test (AITT) by NCVT.
- It has also been observed that some State Directors allow the trainees of un-affiliated Trades/Units to appear for NCVT examination, this should not be done. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET has to face a lot of Court Cases.

- c. In both cases of NC (Not considered) and NR (Not Recommended) Trades/Units, fresh standing Committee inspection are required.

The State Directors are also requested to intimate the institutes concerned about the recommendation with in a month from the date of issue of this letter. Further the SIR in respect of the cases kept under consideration (UC) must be forwarded to this office within three months, failing which the cases will be considered as closed and only fresh SCIR would be required to be submitted and no communication in such cases would be entertained.
