ORDER

As per the Government Order read as 1st paper above, Government had approved the final Seniority list of Group Instructors of Industrial Training Department, as on 30.11.1998.

- 2. As per the judgement read as 3rd paper above, the state of Kerala has been directed to consider Ext. P7 (Letter No. A6/36608/08 dated 01.02.2011 of the Director of Training, TVPM) and to pass appropriate orders there on. As per Ext.P7, the Director of Training has furnished details in connection with the W.P(C) No. 12338/10 filed by Smt. J. Sujatha praying to reassign her seniority in the post of Group Instructor.
- 3. Accordingly, Government have again reviewed the said seniority list in the light of the judgement read as 3rd paper above, in order to comply with the Judgement of Hon'ble High Court
- 4. As per the letters read 2nd, 4th, & 7th papers above, the Training Director, Industrial Training Department has recommended that as Smt. J. Sujatha, Training officer, Related Instruction Centre, Chackai had completed her pre-service Training on 06.07.1998, she is eligible to re-assign her seniority as Group Instructor with effect from 07.07.1998.
- 5. Government have examined the matter in detail after hearing Smt. J. Sujatha in the presence of the officials of the Industrial Training Department and have also issued notice to the affected party as per the memo read as 5th paper above. Accordingly, as per the letter read as 6th paper above, Sri. K.G.Sreekumar, the affected party, Group Instructor, ITI, Chennerkkara (on LWA) has submitted his no objection in the matter.

6. In the circumstances, Government are pleased to amend the Government Order read as 1st paper above partially to the following effect.

The date of seniority of Smt. J. Sujatha as Group Instructors is reassigned as 07.07.1998, and her place, in the Government Order read as 1st paper above, is changed and placed as Sl.No.563 ie, between Sri. S.Jayamohan and Sri. K.C. Subramanian. Subsequently the place in the seniority list of Shri K.C. Subramanian and Shri. K.G.Sreekumar will become 564 and 565, respectively.

The Government order read as 1st paper above stands partially modified to this extent and the judgement read as 3rd paper above is here by complied with.
