list enclosed.


It may clearly be noted that wherever " Not Recommended " (NR)
Not Considered (NC) has been mentioned, in column 5 of the enclosures
actions to be followed are as given below:

concerned institute may be instructed not to admit the trainees
and the trainees, if any undergoing training in such trades/units,
in ITIs/ITCs shall not be permitted to appear in All India Trade Test
(AT) by NCVT.
It has been observed that some State Directors allow the trainees of
unaffiliated trades/units to appear for NCVT examination. This should not be

In both cases of NC (Not Considered) and PR (Not Recommended) trades/units, fresh Standing Committee inspections are required.


