

The institutes/trades, started in 1982 or before, which have not been granted permanent affiliation so far, including those covered in annexures 'A', 'B' and 'C', stand de-recognised.

Any information given in the annexures mentioned above should be deemed to a repetition and not an additional one if any other information/instruction has already been issued or is covered in the above annexures for the same purpose.

6. Any discrepancy observed by you, after comparing the details of the above annexures, with your records may please be brought to the notice of this Directorate. The above annexures do not cover those institutes/trades for which inspection reports have been received after July, 1935. Such reports would be scrutinised in due course of time for considering affiliation.
7. In cases, where conditional affiliation has been granted, State Director is requested to confirm within 3 months that the condition imposed has been met with and the discrepancies have been removed. If confirmation is not received, affiliation granted is likely to be withdrawn.
8. Informations desired vide this Directorate letter No. DWT-5(198) 84-TC dated 18th May, 1935 is not already sent, may please be forwarded immediately as the same is required for the purpose of comparison with our records.

The Standing Committee Inspection Reports (SCIRs), Departmental Inspection Reports (DIRs) and Supplementary Inspection Reports (SIRs) forwarded by you were scrutinised at this Directorate General and recommendations of DGET were placed before the members of the Sub-Committee of NCVT dealing with affiliation in its meeting held on 15.10.1997 at DGET Headquarters, New Delhi. The recommendations of the Sub-Committee made in the meeting on various issues would be issued shortly. A copy of the Statement containing affiliation approval/status for various ITIs/ITCs/Units/Trades with remarks etc., duly signed is enclosed.


On the basis of the above statement, you may please issue the affiliation orders to the Management of the concerned ITIs/ITCs for Trades/Units. In respect of cases where there are deficiencies action be take as under:-

- i) Defects and deficiencies observed, under "Remarks" column 6 are made good within six months i.e. latest by 15th April, 1998 failing which the trainees of such trades/units may not be allowed to appear in the All India Trade Test (AITT) for Craftsmen of July, 1998.
- ii) The conditions of affiliation, if any, are complied with.
- iii) It has been resolved in the meeting that the cases kept "Under Consideration" would be accorded affiliation with the NCVT from the date of their pre-inspection/Standing Committee Inspection, as soon as deficiencies by the institutes are made up i.e. the date of affiliation is to be reckoned from the pre-inspection/ Standing Committee Inspection date for the purpose of declaration of the result. The decision conveyed earlier vide DO letter No. DGET-18017(40)/96-Misc.-TTC dt. 10th July, 1997 may also be kept in view while declaring the result.

You are requested to quote file no. indicated below the institute's name in the statement enclosed in all future correspondence relating to these ITIs/trades/units.

You are requested to communicate to the concerned institute about the approval of affiliation cases immediately under intimation to this Directorate General. Further, the SIR/DIR in respect of the cases kept "Under Consideration" (UC) should be forwarded to this office within six months failing which the case will be considered as closed and thereafter, only fresh SCIRs will be required.
