Subject: Corrigendum to Affiliation Order DGT-Aff011(51)/1/2025-O/o DIR (TC) (E-78713) dated 30.07.2026 on Affiliation of Trades/Units after Conversion from SCVT to NCVET for Government ITI Nagalassery, Kerala - reg.

Madam/Sir,

This is in reference to the Affiliation Order No. DGT-Aff011(51)/1/2025-O/o DIR (TC) (E-78713) dated 30.07.2026, issued in pursuance of the decisions taken at the 32nd SCAA meeting held on 02.07.2026 and 03.07.2026, regarding affiliation of trades/units after conversion from SCVT to NCVET for ITIs in the States of Kerala, Madhya Pradesh and Rajasthan.

2. As per the minutes of the 32nd SCAA meeting issued vide letter dated 22.07.2026, four trades of Government Industrial Training Institute Nagalassery, Velliyamkallu, Thrithala P.O, Palakkad District, Kerala, namely Draughtsman Civil (1+1), Information Technology (1+1), Additive Manufacturing & 3D Printing (1+1) and Computer Aided Embroidery & Designing (1+1), were recommended for NCVET affiliation.

3. However, it has come to notice, that only the first three trades were included in the Affiliation Order dated 30.07.2026, and the trade Computer Aided Embroidery & Designing (1+1), though recommended by the 32nd SCAA, was inadvertently omitted from the list annexed to the said order.

4. The matter has been examined, and the omission is hereby corrected. The entry at Sl. No. 11 (Government Industrial Training Institute Nagalassery) of the Kerala list annexed to the Affiliation Order dated 30.07.2026 shall accordingly be read as under:
